### ***Increasing success in Cameroon***

Over the past few months there have been significant developments in fighting corruption in public services.

Following FITCAM's successful projects in University of Buea, the university Vice-Chancellor has been replaced by a new man, Dr Nalova Lyonga, with demonstrated commitment to the battle against corruption and a record of supporting FITCAM work. On the request of the university, FITCAM also helped with the leadership training for new student leaders in May.

On the back of this work, FITCAM are increasingly involved in the wider battle against corruption. This has included investigations into irregularities in procurement of road works at a village in Limbe area, as well as allegations of tax evasion, with bribery, in Buea.



This picture shows the investigation team inspecting a road works site. This investigation led to saving of a substantial sum of public money, by cleaning up the public procurement of the works.

### ***Corruption and intimidation in Congo***

The final report from the IGI DR Congo project (“Project to fight corruption and intimidation in the university environment in Bukavu”) is now on the IGI website (in French – see DRC page). The project was supported financially by the Swiss development agency. Over eight months, the project brought together a wide range of academics and journalists in a several workshops to explore pressing issues of academic corruption and intimidation, which is rife in eastern DRC. It also involved radio and the Press in educating and sensitizing the public to the issues.

### ***Setting the anti-corruption agenda in Rwanda***

Leaders of IGI in Rwanda, such as Hilaire and Jules attended the International **Conference on Governance and Democracy: an African Perspective** held in Kigali in June and are planning conferences on good governance in secondary schools in the rest of 2012.
